BACKGROUND

Article XII, Section 12.4 of the City's *Charter* provides that a Charter Review Commission shall be appointed not less than every 10 years by the Mayor, with the advice and consent of the Council, to consider whether any amendments to the Charter are proper.

This provision further provides there shall be a representative from each Ward, and that up to two may be elected officials. For many reasons, I have opted to appoint only non-elected officials.

As a result of the 2017 candidate filings, Mr. Don Bartoni (who I had previously included as the Ward 2 appointee) will likely be the next Ward 2 Council Member as he is running unopposed. He has therefore been removed from this list. I recommend Ed Marshall as the Ward 2 representative, given his extensive City experience and that the Commission will not fully engage in decision making until after the April 2017 election (at which time Ed will no longer be an elected official).

Each of the recommended appointees set forth below has been discussed with the respective Council Members for the Ward, and all Council Members are in agreement with the proposed slate of members from their Wards.
