**GRAND TREE** - A tree in fair or better condition which equals or exceeds the following diameter sizes: Large hardwoods (i.e., oaks, hickories, etc.) — twenty-four (24) inch DBH; Large softwoods (i.e., pines, spruces, etc.) — twenty (20) inch DBH; Small trees (i.e., dogwood, redbud, etc.) — twelve (12) inch DBH. A tree in fair or better condition is defined as having a life expectancy of greater than fifteen (15) years, a relatively sound and solid trunk with no extensive decay, no more than one (1) major and several minor dead limbs (hardwoods only), and no major insect or disease problems.

**CALIPER (DBH)** - A measurement of the size of a tree equal to the diameter of its trunk measurement at four and one-half (4 1/2) feet above natural grade. (Diameter at Breast Height = DBH) If a tree splits into two (2) or more trunks below four and one-half (4 1/2) feet, then the trunk is measured at its most narrow point below the split. For newly planted trees the caliper measurement will be taken six (6) inches above natural grade.

### SUBMITTAL REQUIREMENTS

Applications will be considered complete once all applicable documents and fees are received:

- 1.) Completed Application Form
- 2.) Submit one (1) set electronically or two (2) sets of hard copies of an aerial or site plan/survey showing the trees to be removed and any required restoration - The City of Wildwood will keep one (1) copy and one (1) approved copy will be returned, in the format submitted.
